

# F.A. Bregy Elementary School Parent and Family Engagement Policy

In support of strengthening student academic achievement, <u>F.A. #### **Section A: JOINTLY DEVELOPED**

**F.A. Bregy** will take the following actions to involve parents in an organized, ongoing, and timely manner in the planning, review, and improvement of Title I programs, including opportunities for regular meetings, if requested by parents, to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their child and respond to any such suggestions as soon as practicably possible.

• The Bregy School Partners with Bethana and United Communities for family based services both in and outside the school. Bethana provides workshops at Bregy and at the community center located in the community where a lot of our students live. Bethana also provides services to our families with attendance, mental health, family counseling and parenting classes. United Communities provides case management services for our families in need of additional supports.

#### Section G: BUILDING CAPACITY OF PARENTS

**F.A. Bregy** will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

- 1. Providing parents with a description and explanation of the curriculum in use at the school, the forms of academic assessments used to measure student progress, and the achievement levels of the challenging State academic standards; and
- 2. Materials and training to help parents to work with their child to improve their child's achievement, such as literacy training and using technology (including education about the harms of copyright piracy), as appropriate, to foster parent and family engagement

Various workshops and trainings are offered to parents throughout the school year. Some of the topics being covered are Parent portal, School Selection, Summer Learning, Literacy nights and Lexia night. During the Annual Title I meeting, held each September, we share with parents the requirements of Title I, Part A, the State's academic standards and local academic assessments. There are three report card conferences throughout the school year, November, February and April, with an evening conference offered each time. During these conferences teachers will discuss with parents how to monitor their child's progress.

#### Section H: BUILDING CAPACITY OF SCHOOL STAFF

**<u>F.A. Bregy</u>** will provide training to educate teachers, specialized instructional support personnel, principals, and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents, and in how to reach out to, communicate with, and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

Surveys are made available to parents during all events, meetings and conferences. The results of the parent surveys are tallied and shared with staff during Professional developments throughout the school year. In August, staff will be trained on how to communicate and work with parents as equal partners.

- Homework/Newsletter are sent home to keep parents informed of what is being taught in the classroom daily.

- Parent/Teacher Conferences will be held for Quarters 1-3.
- Parents will be notified 10 weeks into each quarter of their child(ren) progress via an interim report
- Parents are invited to make appointments with their child's teacher and/or administration at any point during the year.
- Academic Workshops will be held on the curriculum and intervention programs used at the school for parents
- Quarterly Assembly Programs (Academic, Plays, Concerts)
- Parents will be invited to participate in special days and trips
